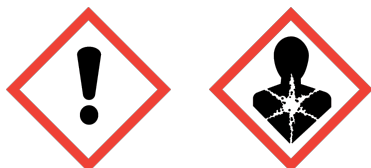

SECTION 4. FIRST AID MEASURES

4.1. Description of first aid measures

General notes
